

TERMS & CONDITIONS OF PHOTO MATCH: PORTFOLIO REVIEW 2020

§ 1 ORGANISER

- 1. The organiser of the PHOTO MATCH: PORTFOLIO REVIEW 2020 taking place as part of the collaboration between Krakow Photomonth Festival and Fotofestiwal in Lodz are the Foundation for Visual Arts, based at ul. Ślusarska 9, Krakow, 30-710 Krakow, KRS 68882 and Fundacja Edukacji Wizualnej based at ul. Tymienieckiego 3, 90-365 Lodz, KRS 0000155981 (hereafter: the Organiser).
- 2. Official e-mail address regarding PHOTO MATCH: PORTFOLIO REVIEW 2020 is portfolio@fotofestiwal.com. Everyone has a right to contact the Organiser for explanation of everything included in Terms & Conditions.

§ 2 PHOTO MATCH: PORTFOLIO REVIEW 2020 PARTICIPANTS

- 1. PHOTO MATCH: PORTFOLIO REVIEW 2020 participants (hereafter: Participants) may be natural persons possessing full legal capacity, who make an entry to the PHOTO MATCH: PORTFOLIO REVIEW 2020 **until June 30th 2020 11:59:59 PM CET**.
- 2. Entry to the PHOTO MATCH: PORTFOLIO REVIEW 2020 takes place via:
 - 2.1. completion and submission of a registration form as well as full acceptance of Terms & Conditions
 - 2.2. submission of digital files with works comprising the Participant's portfolio (format: jpg or png, preferred size 1920 px length).
- 3. Submission and participation are free of charge.

§ 3 DECLARATIONS

- 1. Upon sending the Competition entry, the Participant declares that:
 - 1.1. he/she produced the works presented in his/her portfolio and possesses all and unlimited copyright, and also that the works are not subject to claims from any third person and in particular, they do not infringe the image rights,
 - 1.2. he/she grants the Organiser a free, unlimited territorial licence to use the submitted works for the purposes of the realisation and promotion of the event, Krakow Photomonth Festival, Fotofestiwal in Lodz and the Organiser.
- 2. The Organiser declares that it shall use the licence granted to it with respect for Participants' and any third person personal rights.

§ 4 WINNER OF PHOTO MATCH: PORTFOLIO REVIEW 2020

- 1. Two winners shall be selected by the Organiser from all of the Participants.
- 2. The winners shall be selected after consulting with reviewers of the PHOTO MATCH: PORTFOLIO REVIEW 2020 as well as with jury consisting of one representative of Krakow Photomonth Festival and one representative of Fotofestiwal in Lodz. Decision on the selection of the winners shall be announced at the Krakow Photomonth Festival and Fotofestiwal in Lodz's websites www.photomonth.com and www.fotofestiwal.com until August 16th 2020. The above decision is final.
- 3. The Organiser shall contact winners via e-mail address submitted in the registration form.

§ 5 PRIZE

- 1. As the prize to be awarded to the winners of PHOTO MATCH: PORTFOLIO REVIEW 2020, the Organiser shall organise an exhibition for one winner in the next edition of the Krakow Photomonth Festival 2021 and another winner in the next edition of Fotofestiwal in Lodz 2021.
- 2. The Organiser reserves the right to select joint winners or not to award the prize at all.

§ 6 PERSONAL DATA

- 1. The administrator of Participants' personal data are the Foundation for Visual Arts based at ul. Ślusarska 9, 30–710 Kraków, registered in the National Court Register under the number KRS: 0000068882 and Fundacja Edukacji Wizualnej based at ul. Tymienieckiego 3, 90-365 Lodz, KRS 000015598, hereinafter referred to as the Administrator. The purpose of collecting data is to recruit applications for PHOTO MATCH: PORTFOLIO REVIEW 2020, implementation of PHOTO MATCH: PORTFOLIO REVIEW and publication of the results of PHOTO MATCH: PORTFOLIO REVIEW 2020. The basis for the processing of personal data of Participants is the legitimate interest of the Administrator.
- 2. Participants have the right to access the data content and rectify, delete or limit processing, as well as the right to object, request to stop processing and transferring data, as well as the right to withdraw consent at any time and the right to file a complaint to the supervisory body (President of the Personal Data Protection Office).
- 3. Providing data is voluntary, however necessary to participate in PHOTO MATCH: PORTFOLIO REVIEW 2020.
- 4. Personal data may be transferred to authorized bodies to the extent required by law and entities providing services to the Administrator. Shared
